



INVITATION TO TENDER

REPAIRS TO A SECTION OF THE PERIMETER FENCE AT ANR ROBINSON INTERNATIONAL AIRPORT – PHASE 1

Airports Authority of Trinidad and Tobago (the 'Authority') invites sealed Tenders from suitably qualified companies/firms who are registered in Trinidad and Tobago for the:

"REPAIRS TO A SECTION OF THE PERIMETER FENCE AT ANR ROBINSON INTERNATIONAL AIRPORT – PHASE 1"

Tender Documents may be perused at the Information Resource Centre, Airports Administration Centre, South Terminal, Piarco International Airport, Golden Grove Road, Piarco and the Administration Building, ANR Robinson International Airport, Crown Point, but can only be taken away upon payment of a non-refundable Tender Fee of One Thousand Dollars (\$1,000.00). Documents will be available from **Monday 31st January, 2022**. **A copy of the receipt must be submitted with the Tender.**

Prospective Tenderers are required to attend a **Mandatory Virtual Pre-Tender Meeting** to acquaint themselves with conditions which may influence their Tender. The **Mandatory Virtual Pre-Tender Meeting** shall be held on **Friday 11th February, 2022 at 10:00 a.m.** Prospective Tenderers are also required to attend a **Mandatory Site Visit** at the **ANR Robinson International Airport, Tobago** on one of the following days: **14th, 15th or 16th February, 2022**, at times to be advised.

In order to obtain the meeting link and an assigned date and time to attend the **Mandatory Site Visit**, Prospective Tenderers must email the Corporate Secretary at corporate_secretary@tntairports.com on or before **Wednesday 9th February, 2022 at 12:00 noon** with the subject **"Repairs to a section of the Perimeter Fence at ANR Robinson International Airport – Phase 1"**

Tenderers must submit **two (2) opaque sealed envelopes**, one (1) containing the **Technical Bid** and the other containing the **Financial Bid**. Envelope one (1) (marked 'Technical Bid') shall contain **one (1) Original, one (1) Hard Copy and one (1) PDF copy on a flash drive or CD** of the Technical Bid and Envelope two (2) (marked 'Financial Bid') shall contain **one (1) Original, one (1) Hard Copy and one (1) PDF copy on a flash drive or CD** of the Financial Bid. The envelopes must be clearly labelled:

LATE TENDERS WILL NOT BE CONSIDERED IN ANY CIRCUMSTANCES.

The Authority will not defray any cost incurred by Tenderers during the preparation and/or submission of their Tenders.

Failure to attend the Mandatory Virtual Pre-Tender Meeting and Site Visit will result in disqualification of the Tender.

The Authority does not bind itself to accept the lowest or any other Tender.
