The Airports Authority of Trinidad and Tobago (the Authority) invites sealed Tenders from suitably qualified companies for the following project:

### **"ANRRIA RUNWAY AND TAXIWAY PAVEMENT REHABILITATION A.N.R. ROBINSON INTERNATIONAL AIRPORT, TOBAGO"**

Copies of Tender Documents can be obtained upon payment of a non-refundable Tender Fee of US\$200.00 at the Administration Centre, South Terminal, Piarco International Airport, Trinidad and at the Administration Centre of the ANR Robinson International Airport, Crown Point, Tobago from June 12, 2017. **(A copy of this receipt must be submitted with the tender).**

Prospective tenderers are required to attend a **Mandatory Pre-Tender site visit** to acquaint themselves with the conditions which may affect their tendering. The Authority does not bind itself to accept the lowest or any other Tender.

Failure to attend the mandatory pre-tender site meeting will result in disqualification of the tender.
