LEASING OF COMMERCIAL SPACE NORTH TERMINAL PIARCO INTERNATIONAL AIRPORT

Airports Authority of Trinidad and Tobago ("the Authority") invites suitable business entities to submit an Expression of Interest (EOI) for the **leasing of space on the Ground Floor, Landside West area, North Terminal, Piarco International Airport.**

This space is situated in a high foot traffic area within the terminal building, adjacent to the western entrance, in the vicinity of the arrivals corridor.

Proposers are asked to present a business concept which falls into one of the following categories:

- Gift retail store;
- Variety store;
- Electronics; and
- Consideration will be given to services that are not currently offered.

The EOI document may be perused at the Information Resource Centre, Airports Administration Centre, South Terminal, Piarco International Airport, Golden Grove Road, Piarco. Documents will be available from **Tuesday 17th September 2019.**

Prospective proposers are invited to attend a **mandatory** Pre-Proposal meeting and Site Visit to acquaint themselves with the conditions therein, which may influence their submission on **Monday 30th September 2019 at 10:00 a.m.** at the Emergency Operations Centre (EOC), Upper Floor, North Terminal, Piarco International Airport.

Proposers must submit one (1) original document and five (5) copies of the proposal in letter format (i.e. 8 1/2 x 11) in an opaque sealed envelope. The envelope must be marked "ORIGINAL" or "COPY" as appropriate and must be clearly labelled:

Proposals submitted by means of facsimile or email will not be considered.

Failure to attend the mandatory pre-proposal meeting and site visit will result in the disqualification of the proposal.

The Authority does not bind itself to accept the lowest or any other Proposal.
