



INVITATION TO TENDER

INSTALLATION OF A NEW ROOF LOCATED AT THE SOUTH TERMINAL, PIARCO INTERNATIONAL AIRPORT

Airports Authority of Trinidad and Tobago (the Authority) invites sealed Bids from suitably qualified companies/firms who are incorporated/ registered in Trinidad and Tobago for the:

**"INSTALLATION OF A NEW ROOF LOCATED AT THE SOUTH TERMINAL,
PIARCO INTERNATIONAL AIRPORT."**

Tender Documents may be perused at the Information Resource Centre, Airports Administration Centre, Piarco International Airport, South Terminal, Golden Grove Road, Piarco but can only be taken away upon payment of a non-refundable Tender Fee of Five Hundred Dollars (\$500.00). Tender Documents will be available from **January 14th 2022**. **A copy of the receipt of purchase of the Tender Documents must be submitted with the Bid.**

Prospective Tenderers are required to attend a **mandatory pre-bid meeting and Site Visit** to acquaint themselves with conditions which may influence their Bid. The Mandatory Pre-Bid Meeting and Site Visit are scheduled for **Tuesday 18th January 2022 at 10:00 a.m. at the Human Resource Meeting Room, Airports Administration Centre, South Terminal, Golden Grove Road, Piarco.**

Tenderers must submit one (1) original, one (1) hard copy and one (1) PDF copy on a flash drive of their Bid, in a sealed envelope labelled:

"Installation of a New Roof located at the South Terminal, Piarco International Airport."

The envelope must be deposited in the Tender Box located in the Lobby of the Airports Administration Centre no later than **2:00 p.m. on Tuesday 15th February 2022.**

Bids will be opened publicly shortly thereafter at **2:30 p.m.** Tenderers or their representatives may be present at the opening.

LATE TENDERS WILL NOT BE CONSIDERED IN ANY CIRCUMSTANCES. Bids submitted by means of facsimile or email shall not be considered.

A Tenderer who participates in or submits more than one Proposal shall cause all Proposals submitted to be rejected.

The Authority will not defray any cost incurred by Tenderers during the preparation and/or submission of their Bids.

Failure to attend the mandatory Pre-Bid Meeting and Site Visit will result in disqualification of your bid.

The Authority does not bind itself to accept the lowest or any other Tender.
