# INVITATION TO TENDER

## **PACKAGE 2 – REPLACEMENT OF THE PERIMETER FENCE FROM THE IBIS GATE TO THE RAPID EXIT GATE AT THE PIARCO INTERNATIONAL AIRPORT**

Airports Authority of Trinidad and Tobago (“the Authority”) invites sealed tenders from suitably qualified companies/firms who are incorporated/registered in Trinidad and Tobago for:

### **“PACKAGE 2 - REPLACEMENT OF THE PERIMETER FENCE FROM THE IBIS GATE TO THE RAPID EXIT GATE AT THE PIARCO INTERNATIONAL AIRPORT”**

Tender Documents may be perused at the Information Resource Centre, Airports Administration Centre, Piarco International Airport, South Terminal, Golden Grove Road, Piarco but can only be taken away upon payment of a non-refundable Tender Fee of One Thousand Dollars (TT\$1,000.00). Documents will be available from **Monday 11th November 2019. A copy of this receipt must be submitted with the Bid.**

Prospective Tenderers are required to attend a **mandatory Pre-Bid meeting and Site Visit** to acquaint themselves with conditions which may influence their tender. The Pre-Bid Meeting and Site Visit are scheduled for **Tuesday 12th November 2019 at 1:30 p.m. at the Airports Administration Centre, Piarco International Airport, South Terminal, Golden Grove Road, Piarco.**

Tenderers must submit one (1) opaque sealed envelope, containing the Proposal. The envelope shall contain one (1) original, one (1) hard copy and one (1) PDF copy on a flash drive and must be clearly labelled:

**LATE TENDERS WILL NOT BE CONSIDERED IN ANY CIRCUMSTANCES. Tenders submitted by means of facsimile or email shall not be considered.**

The Authority will not defray any cost incurred by the Tenderers during the preparation/submission of their tender.

**Failure to attend the mandatory Pre-Bid Meeting and Site Visit will result in disqualification of the submitted tender.**

The Authority does not bind itself to accept the lowest or any other tender.
