INVITATION TO TENDER

REPAIRS TO PERIMETER FENCE AT THE ANR ROBINSON INTERNATIONAL AIRPORT

The Airports Authority of Trinidad and Tobago (the "Authority") invites sealed Bids from suitably qualified companies/businesses for the:

"Repairs to Perimeter Fence at the ANR Robinson International Airport"

Tender Documents may be perused at the Information Resource Centre, Airports Administration Centre, Piarco International Airport, South Terminal, Golden Grove Road, Piarco and Accounts Department, Airports Administration Building, ANR Robinson International Airport, Crown Point, but can only be taken away upon payment of a non-refundable Tender Fee of One Thousand Trinidad and Tobago Dollars (TT\$1,000.00) to the cashier at the Airports Administration Centres, both at Piarco and ANR Robinson International Airports. Tender Documents will be available from **Wednesday 25th September, 2019. A copy of the receipt of purchase must be submitted with the Bid.**

Prospective Tenderers are required to attend a **mandatory Pre-bid Meeting and Site Visit** to acquaint themselves with conditions which may influence their Tender. The mandatory Pre-Bid Meeting and Site Visit are scheduled for **Wednesday 2nd October, 2019 at 1:30 p.m. at the Conference Room, Airports Administration Building, ANR Robinson International Airport, Crown Point.**

Tenderers must submit **two (2) opaque sealed envelopes**, one (1) containing the **Technical Bid and the other containing the Financial Bid**. Envelope 1 (marked 'Technical Bid') shall contain one (1) original, one (1) hard copy and one (1) soft copy in Portable Document Format (PDF) on a flash drive of the Technical Bid, and Envelope 2 (marked 'Financial Bid') shall contain one (1) original and one (1) hard copy and one (1) soft copy in Portable Document Format (PDF) on flash drive or CD of the Financial Bid. The opaque sealed envelopes must be clearly labelled:

"Repairs to Perimeter Fence at the ANR Robinson International Airport"

The envelopes must be deposited in the appropriately labelled Tender Box located in the Lobby of the Airports Administration Centre, Piarco International Airport, South Terminal, Golden Grove Road, Piarco, Trinidad no later than **2:00 p.m. on Friday 1st November, 2019.**

The Tenders will be opened publicly shortly thereafter at **2:30 p.m.** Tenderers or representatives may be present at the opening.

LATE TENDERS WILL NOT BE CONSIDERED IN ANY CIRCUMSTANCES. Tenders submitted by means of facsimile or email shall not be considered.

The Authority will not defray any cost incurred by Tenderers during the preparation and/or submission of their Bids.

Failure to attend the mandatory Pre-Bid Meeting and Site Visit will result in the disqualification of the submitted bid.

The Authority does not bind itself to accept the lowest or any other tender.
