The Airports Authority of Trinidad and Tobago ("the Authority") invites sealed Bids from suitably qualified companies/firms who are registered in Trinidad and Tobago for the:

"REHABILITATION TO THE PERIMETER ROAD FROM OLD BEL-AIR TO WESTERN ENTRANCE OF SOUTH RAMP AND ASPHALT PATCHING AT THE CARIBBEAN AIRLINES AND BRISTOW HANGARS, PIARCO INTERNATIONAL AIRPORT"

Tender Documents may be perused at the Information Resource Centre, Airports Administration Centre, South Terminal, Piarco International Airport, Golden Grove Road, Piarco but can only be taken away upon payment of a non-refundable Tender Fee of One Thousand Dollars (\$1,000.00). Documents will be available from **Monday 12th November 2018**. **A copy of this receipt must be submitted with the Bid.**

Prospective Tenderers are required to attend a **mandatory Pre-Tender Meeting and Site Visit** to acquaint themselves with conditions which may influence their tender. The Pre-Bid Meeting and Site Visit are scheduled for **Thursday 15th November 2018 at 1:00 p.m. at the Human Resource Training Room, Airports Administration Centre, South Terminal, Piarco International Airport, Golden Grove Road, Piarco.**

Tenderers must submit one (1) ORIGINAL, one (1) hard COPY and one (1) soft copy in Portable Document Format (PDF) on a flash drive of the Tender, in sealed envelopes with label:

LATE TENDERS WILL NOT BE CONSIDERED IN ANY CIRCUMSTANCES. Tenders submitted by means of facsimile or email shall not be considered.

The Authority will not defray any cost incurred by Tenderers during the preparation and/or submission of their tenders.

Failure to attend the mandatory Pre-Tender meeting and site visit will result in disqualification of the submitted tender.

The Authority does not bind itself to accept the lowest or any other tender.
